Sub: VNRVJIE- Exam Branch-Conduct of One Time Chance Examination for Sem End Examinations and conduct of Exam for Internal marks improvement for the students of U.G & P.G Courses – Regarding.

With reference to the vide reference 1&2 cited above, The Directorate of University Examinations has accorded the permission to conduct the Sem End Examination and also Test for improvement of internal marks for the students who have completed their course work and completed the stipulated number of attempts to clear their backlog subjects and did not get the degree.


With reference to the cited ref.3 above, The Examination branch-VNRVJIE is proposed to conduct one-time chance sem-end examinations as well as test for improvement of internal marks for U.G courses and it is proposed to conduct One-time chance sem-end Examination only for P.G courses, as there is no scope for conduct of test for improvement of internal marks due to re-registration facility was already there after R09 regulation. However, PG students are allowed to submit their Dissertation work, without having any backlogs in order to conduct Project Viva voce examinations to get their degree. The One time chance is applicable to the students who have completed their maximum duration of course work (Eight years for B.Tech and 4 years for M.Tech courses) and did not get the degree due to exhaustion of the stipulated number of attempts to clear their backlog subjects. The details of regulations for which the test for Internal improvement of marks and Sem End Examinations have to be conducted are as follows.

Hence, we request you to kindly make necessary arrangements to inform the same to all passed out students of the above regulations through appropriate communication system and direct them to register (through offline) at student service centre-VNRVJIET **on or before 05-04-2024** for One-Time-Chance Examination, which are proposed to be conducted from **01-05-2024**.

The Timetables for the conduct of test for **Internal marks improvement** as well as **One Time Chance Semester End Examination** shall be issued shortly along with the list of eligible candidates.

The detailed FAQs are given as **Annexure-A** to this letter for understanding the scope of the eligibility criteria to appear for **One-Time Chance Semester End Examination**.
