With reference to the University order (1) cited above, the JNTUH has approved for adding grace marks of 0.50% of total marks for any number of theory subjects as mentioned below for B.Tech. R18,R19 and A19 Regulations, and for the students admitted in previous regulations and completed fourth year under R18/R19/A19 regulations, without subject exemption, who are eligible to get degree in the academic year 2021-22, 2022-23, 2023-2024 and 2024-2025 only.

The grace marks shall be applicable to only for B.Tech. (R18, R19 and A19 Regulations) 2018, 2019, 2020 and 2021 regular, 2019, 2020, 2021 and 2022 lateral entry admitted batch students and for the students admitted in previous regulations and completed fourth year under R18, R19 and A19 regulations, without subject exemption, who are eligible and supposed to get degree in the academic year 2021-22, 2022-23,2023-24 and 2024-2025 only.

With reference to the vide reference no.2, the JNTUH has approved for adding grace marks of 0.50% of total marks for any number of theory subjects as mentioned below for all B.Tech. R18, R19,A19 Regulations and for the students admitted in previous regulations and completed fourth year in R18, R19,A19 regulations, without subject exemption, who are eligible and supposed to get degree in the academic year 2021-22, 2022-23, 2023-24,2024-2025 only.

In view of the above, The Examination branch VNRVJIET, invites applications from all eligible students of the above regulations only to avail the grace marks service.

Those students, who are eligible to apply for grace marks up to maximum 30 marks for Regular and 23 marks for Lateral entry students for any number of Theory subjects only. The performance in the examinations for which results are awaited and / or RC, RV & CV, shall be nullified if they apply for the PC & CMM under grace marks service. They shall not be permitted to write any future examinations.

For all other batch students as well as other regulation students, the above grace marks will not be applicable and they have to satisfy their applicable rules and norms as per their academic regulations for getting the degree.

The students are requested to note the following information for availing grace marks.

- 1. A Separate form (Form-5) earmarked for grace marks service need to be filled up and submit the same at the Examination branch-VNRVJIET.
- 2. Marks shall be added up to 30 marks for four-year B.Tech. course in failed subjects and 23 marks for Lateral entry students of Three-year B.Tech. course.

The Applications received as per the format (Form No.5. leaving Internal & External Marks as blank) by 07-07-2025 before 5 P.M shall be processed and efforts will be made to issue PC &CMM under grace marks subjected to the Approval given by JNTUH.

Note: The last date for applying to avail the grace marks is 07-07-2025.
